Developed and coherent system of legal regulation is a precondition for sustainable and effective development of the knowledge based society. Negotiations and adoption by states of random international treaties through various and often not coordinated international organizations covering global and regional levels of association often rather produce chaos than create a framework for functional system of norms. For coordinated support to development of knowledge based society it is indispensable to set up a functional system of norms, where on global and regional international levels are undertaken concerted efforts focused on this issue. Therefore, this topic is of importance to be addressed, when the support to the development of knowledge based society through knowledge management is discussed.

- Harmonization of International Law as Precondition for the Development of Knowledge based Society
- EU and Knowledge based Society

- ICT Worldwide Legal Regulation as an Instrument for Faster Development of Knowledge based Society

Full paper: Only required when the abstract has been selected and not to be more than 5,000 words including abstract, keywords and references (the Harvard referencing rules need to be followed). Submission date will be no later than **2 April 2010**. Papers should be submitted as .doc or .rtf file attachments by email to the Conference Manager, Elaine Hayne_at Elaine.hayne@academic-conferences.org

The selection panel of the conference committee will consider all abstracts received by the submission deadline to ensure that the proposed paper is relevant to the Conference. The authors of abstracts that describe a relevant paper will receive a notification of abstract selection. All full papers will be double-blind reviewed by members of the conference committee to ensure an adequate standard, that the proposed subject of their abstract has been followed, that the paper is of a suitable length, the standard of English is adequate and the paper is appropriately referenced. For authors whose first language is not English we request that you have your work proofread preferably by a native English speaker prior to submission (or at least a fluent English speaker) – papers may be rejected due to a poor standard of English. Papers that are accepted will be published in the conference proceedings providing at least one author registers and presents the work at the Conference (see the registration section of the conference website for more information about registration).

Due to the large number of papers expected for this conference, the committee only allows an author to present one paper. Therefore if multiple papers are accepted for presentation different co-authors need to present each paper. Please direct enquiries to Elaine.hayne@academic-conferences.org

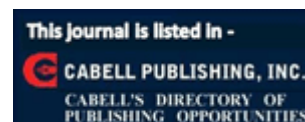
