Sustainable Knowledge-based development is the objective of all societies in an interdependent era characterised by resource constriction and efflorescence of science and technology. In a knowledge-based society, the bar is raised from the development goal of industrialisation, focusing solely in tangible assets, to an economy based on the capitalisation of knowledge. This track addresses the concept of sustainable knowledge management and its linkages with other fields of management in coping with complex, transient and diversity contexts. It is intended to create a forum for discussion of the latest research findings that suggest the combinative use of different methodologies developed in different disciplines regarding sustainable knowledge management.

Possible topics include, but are not limited to:

- Re-thinking Knowledge Management - The emergence of polyvalent Knowledge (using three-dimensional thinking - Economy, Environment and Society)
- Collaborative relationships towards sustainable knowledge generation, transfer and development
- Learning for Sustainability
- Application of Sustainability principles in existing knowledge management approaches (knowledge harvesting, communities of practice, storytelling, etc.)
- The critical success factors of Sustainable Knowledge Management
- Other topics

Abstract details: The Abstract should be a minimum of 300 and no more than 500 words including up to five keywords and keyphrases to be received by **12 February 2010**. Please read the abstract guidelines section of the website before submitting.

Full paper: Only required when the abstract has been selected and not to be more than 5,000 words including abstract, keywords and references (the Harvard referencing rules need to be followed). Submission date will be no later than **2 April**

The selection panel of the conference committee will consider all abstracts received by the submission deadline to ensure that the proposed paper is relevant to the Conference. The authors of abstracts that describe a relevant paper will receive a notification of abstract selection. All full papers will be double-blind reviewed by members of the conference committee to ensure an adequate standard, that the proposed subject of their abstract has been followed, that the paper is of a suitable length, the standard of English is adequate and the paper is appropriately referenced. For authors whose first language is not English we request that you have your work proofread preferably by a native English speaker prior to submission (or at least a fluent English speaker) – papers may be rejected due to a poor standard of English. Papers that are accepted will be published in the conference proceedings providing at least one author registers and presents the work at the Conference (see the registration section of the conference website for more information about registration).

Due to the large number of papers expected for this conference, the committee only allows an author to present one paper. Therefore if multiple papers are accepted for presentation different co-authors need to present each paper. Please direct enquiries to Elaine.hayne@academic-conferences.org
