Communities of practice (CoPs) have become a theoretical focus for scholars during last two decades and increasingly developed by organizations. CoPs constitute a solution for improving performance and managing knowledge and intellectual capital. Despite the fact of usefulness of CoPs for *problem solving, collative learning, creativity, innovation, and knowledge sharing in teams and organizations*, the literature is still uncertain concerning the manageability of CoPs and there is not enough empirical research regarding the role of leaders in the process of creativity and innovation in CoPs. The key intention of this call is to bring together economists and other social scientists doing field or lab experiments in the above areas of research to present and discuss work in progress.

- Communities of Practice
- Creativity Management
- Knowledge Sharing
- Leadership in Knowledge-based organizations
- Management of Innovation
- Other topics

Abstract details: The Abstract should be a minimum of 300 and no more than 500 words including up to five keywords and keyphrases to be received by **22 April 2010**. Please read the abstract guidelines section of the website before submitting.

Full paper: Only required when the abstract has been selected and not to be more than 5,000 words including abstract, keywords and references (the Harvard referencing rules need to be followed). Submission date will be no later than **10 June 2010**. Papers should be submitted as .doc or .rtf file attachments by email to the Conference Manager, Elaine Hayne at Elaine.hayne@academic-conferences.org

The selection panel of the conference committee will consider all abstracts received by the submission deadline to ensure that the proposed paper is relevant to the Conference. The authors of abstracts that describe a relevant paper will receive a notification of abstract selection. All full papers will be double-blind reviewed by members of the conference committee to ensure an adequate standard, that the proposed subject of their abstract has been followed, that the paper is of a suitable length, the standard of English is adequate and the paper is appropriately referenced. For authors whose first language is not English we request that you have your work proofread preferably by a native English speaker prior to submission (or at least a fluent English speaker) – papers may be rejected due to a poor standard of English. Papers that are accepted will be published in the conference proceedings providing at least one author registers and presents the work at the Conference (see the registration section of the conference website for more information about registration).

Due to the large number of papers expected for this conference, the committee only allows an author to present one paper. Therefore if multiple papers are accepted for presentation different co-authors need to present each paper. Please direct enquiries to Elaine.hayne@academic-conferences.org
