He holds a doctorate in industrial engineering and management (Ph.D. in Tech) and also possesses a Master of Laws and a Master of Science in Economics. His primary research interests include the development of micro-enterprises, public business services, start-ups, eHealth business, public procurement, and regional development. In recent

years, he has been involved in numerous projects focusing on digital development in SMEs.
